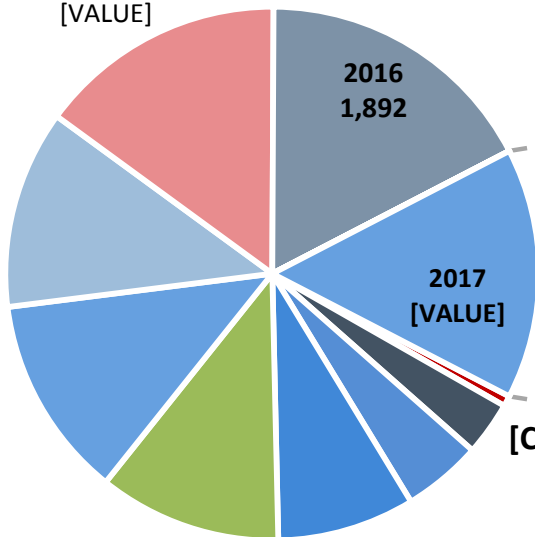

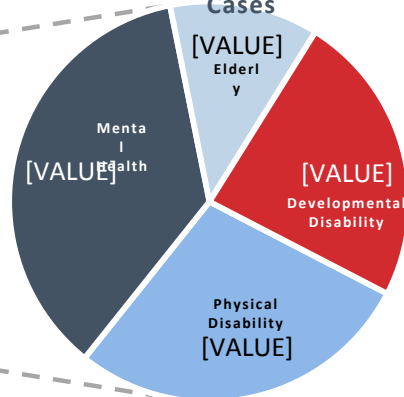

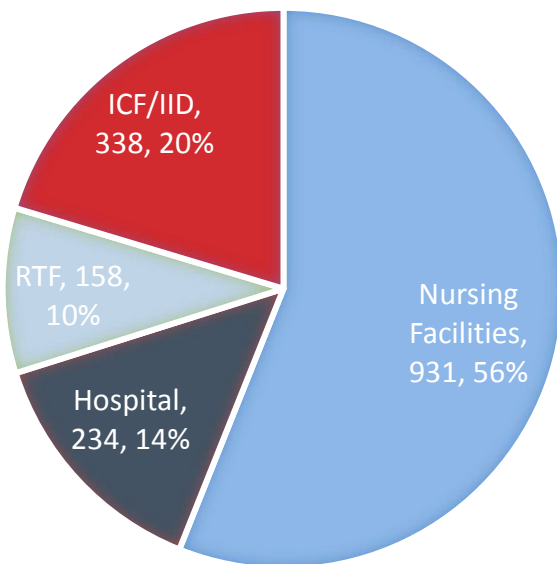
Breakdown: Total Active Cases



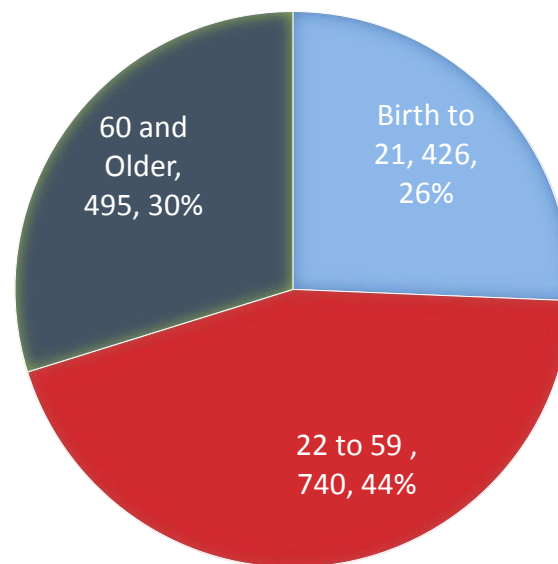

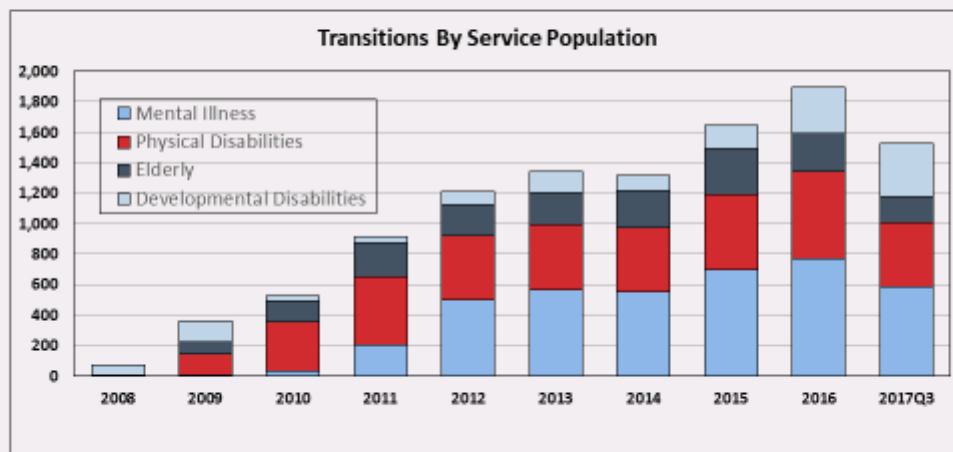
CURRENT HOME CHOICE TRANSITIONS

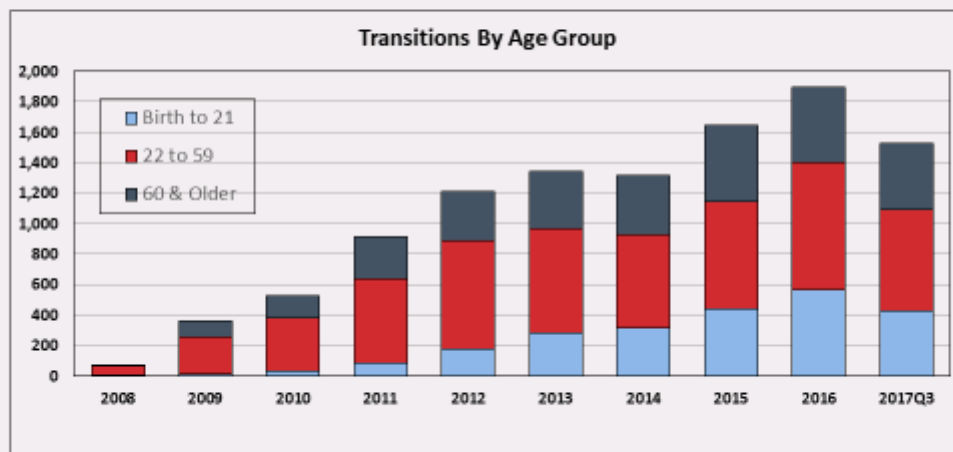
TRANSITIONS BY INSTITUTION



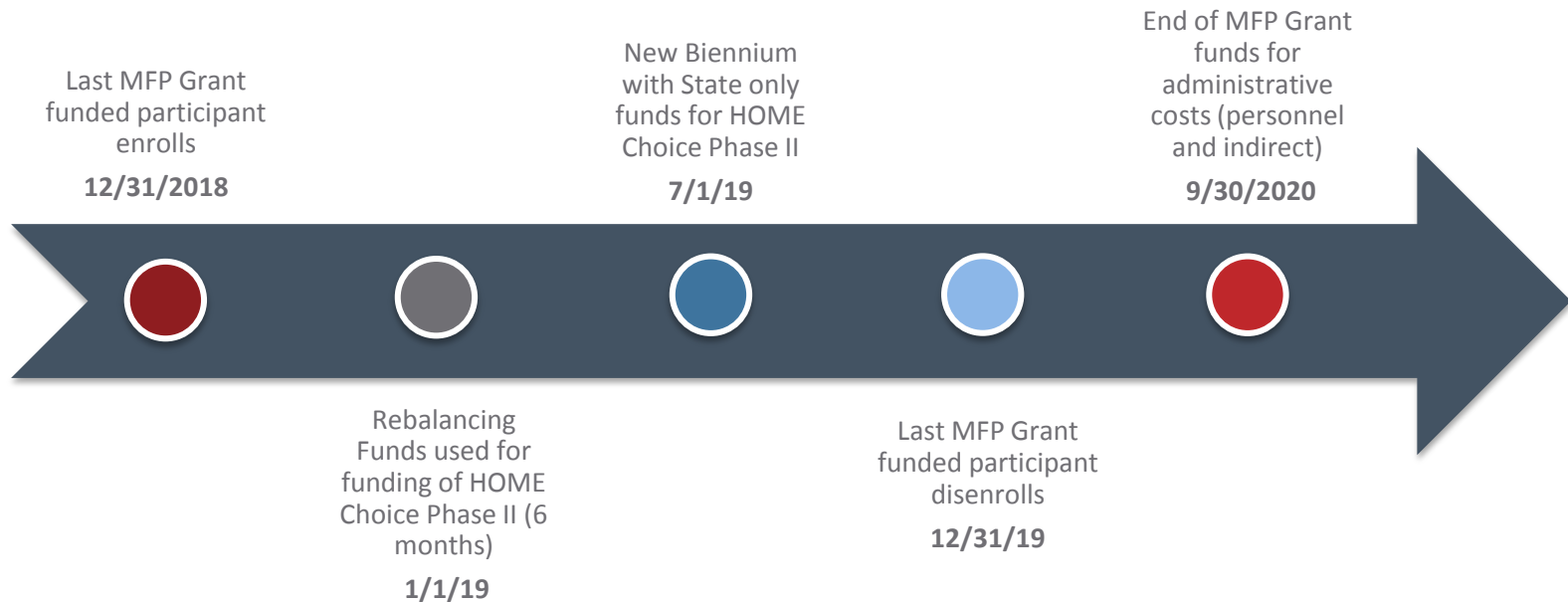
TRANSITIONS BY AGE GROUP







HOME Choice Timeline



- 12/31/2018 Last MFP Grant funded participant enrolls
- 1/1/2019 Rebalancing Funds used for funding of HOME Choice Phase II (6 months)
- 7/1/2019 New Biennium with State only funds for HOME Choice Phase II
- 12/31/2019 Last MFP Grant funded participant disenrolls
- 9/30/2020 End of MFP Grant funds for administrative costs

HOME Choice

- **Financial Status: Subject to change!**
 - » Grant Budget Alignment – Very fluid process
 - MFP Grant today
 - HOME Choice programmatic changes made since July 1, 2017
 - All about Right Sizing the program for the duration of the grant

HOME Choice

- **Financial Status: Subject to change!**
 - » January 1, 2019
 - State Funds/Rebalancing Funds expected to bridge the gap through June 30, 2019
 - Parallel Programs in place on January 1, 2019
 - MFP Grant enrollees paid by the grant through their 365 in 2019
 - HOME Choice II – State funded transition program begins

HOME Choice

- **HOME Choice II**

- » Lots of dialogue & approaches being explored:

- Add services to waivers
- Add services to State Plan
- Internal ODM Collaborative efforts underway

HOME Choice

- **HOME Choice II**

- » Preparing for next Biennium Budget Submission

- Looking ahead to July 1, 2019 – June 30, 2020
- Submit state budget request to ODM leadership summer 2018
- Monitor budget review process with OBM & Legislators
- Advocacy Role

 - » Internal HOME Choice Workgroups
 - Data analysis
 - Discussion
 - » Senior Leadership Role
 - Presentation
 - Decisions made to determine next steps for HOME Choice
