In the past 10 years ...


 Historically experienced poor reimbursement rates and prolonged period without rate increases

COVID-19

 In Ohio and nationwide, many adult day services closed during the COVID-19 pandemic and did not reopen


In 2024 ...

HOUSE BILL 45

- Monumental investments in aging services
- Part of Governor DeWine's 2023 State of the State initiatives
- Allocated \$8 million for Adult Day Providers that operated prior to the Covid-19 Pandemic
 - How can these funds be invested into the sector meaningfully?
 - Opportunities for impact



ADULT DAY IMPACTED INDUSTRY PROGRAM

Encourage new providers to join and previous providers to return to the adult day services industry Support existing providers in expanding their service capabilities for long-term sustainability

 - Working with 'at risk' centers




CURRENT ADS LANDSCAPE

WHAT CONSTITUTES QUALITY FOR ADULT DAY SERVICES?

- Make eye contact with your audience to create a sense of intimacy and involvement
- Weave relatable stories into your presentation using narratives that make your message memorable and impactful
- Encourage questions and provide thoughtful responses to enhance audience participation
- Use live polls or surveys to gather audience opinions, promoting engagement and making sure the audience feel involved

WHAT CONSTITUTES QUALITY FOR ADULT DAY SERVICES, CONT.

Activity Programming

- Person-centered
- Activity calendar with multiple activities and for a variety of interests
- Meaningful Engagement
 - Physical
 - Emotional
 - Mental
 - Spiritual
 - Fun





"My mom receives attention and activity engagement that she was not receiving at home using a private caregiver while I was working during the day."

WHAT CONSTITUTES QUALITY FOR ADULT DAY SERVICES, CONT.

Staffing

- Active Engagement
- Trained to meet needs
- Adequate staffing levels

Transportation

- Must meet the needs of the ADS participant
 - Curb to curb
 - Door thru Door or Caregiver to

Caregiver



Meals and Snacks

- Nutritious, tasty
- Culturally appropriate
- Diet modifications


